

LOCATION:

This industrial unit is located on the established east part of the Northfleet Industrial Estate with access of the main spine road to the Estate.


Northfleet is set in the heart of the Thames Gateway Development Area with large scale development and infrastructure improvements, including Bluewater Park Shopping Centre, Ebbsfleet International, CTRL and STDR, all within the locality. Northfleet is located two miles east of Dartford and three miles west of Gravesend within two miles of Junctions 1a and 2 of the M25. The new Ebbsfleet International is circa 0.7 south of the property.

Northfleet Industrial Estate is situated off the A226 Galley Hill Road. Unit F15 can be found at the rear of the estate. Once on the estate, take the left fork opposite the lake and Unit F15 is on the right-hand side mid terrace.

DESCRIPTION: The property comprises a single storey mid-terrace business unit built in the 1980's, with ground floor set out to two WCs single office and workshop/warehouse together with a half level mezzanine floor fitted out to offices and a kitchen.

The unit is of a steel portal frame construction with a single roller shutter door. The loading door is 2.705m wide and 3.424 m high. There is a small parking/loading area to the front.
