LOCATION: Just off the A25, near Sevenoaks, this modern self-contained first floor suite of offices within Block D is located on the established Chaucer Business Park in Kemsing, adjoining the railway station. The Unit can be found in the centre of the park just to the right hand side of Chaucer House.

Kemsing is located three miles east of Sevenoaks, about twelve miles west of Maidstone and seven miles south of Swanley. The Business Park is situated a short distance north of the A25 at Seal and is within easy reach of Junction 5 of the M25/A25/M26 at Sevenoaks and Junction 2 of the M26/M20 at Wrotham.

The property adjoins Kemsing railway station with an approximate journey time to London Victoria of 40 minutes.

DESCRIPTION: Chaucer Business Park comprises a high quality modern purpose built business park set in seven main terraces, which together with adjoining industrial estate, has a total of 72 units. The suite is situated at the end of Block D with a self-contained ground floor access.

This self-contained suite of offices comprises three partitioned offices, together with an open plan office area. The offices are fitted to wallpapered walls, suspended ceiling and carpet floor cover. They are air conditioned and have central heating. There are both male and female toilets plus kitchenette.
